General information & rental terms

Cancellation

- For a one day shoot there is a 50% cancellation fee for cancellation between 24 & 48 hours and 100% fee for cancellation within 24 hours before a confirmed booking.
- Cancellation of a confirmed booking must provide for a minimum period of at least the length of the entire booking with a minimum of two business days. Should a booking be cancelled with less than the prescribed notice, a cancellation fee of 50% of the total base fee will be charged.
- Part cancellation & postponements of confirmed bookings are subject to the above conditions.

Confirmation

- A booking request will not be accepted unless a signed booking form is received or in case of short notice, an email, acknowledging & accepting all terms & conditions.

Stock library shoots

- Stock library footage (of any nature) may **NOT** be shot at The Daylight Studio under any circumstances. This is non-negotiable & management reserves the right to terminate any such shoot and pursue legal action for breach of contract.

Electricity

- The Studio is equipped with 50 amps power supply (several power points & extensions available).
- Three-phase plug is used for the hoist and available on request.
- We don't have a generator and are not liable in case of power failure for any reason.

Cleaning

- When the rental period is finished, the studio must be left ready for the next renter. If cleaning, painting and or pickup is needed, costs will be charged to the renter.

Equipment Hoist

- The motorised hoist may be used free of charge to transport equipment, props and furniture to the studio from street level. It is operated by Daylight staff only, this is non-negotiable.
- Maximum load weight is 120kg.
- The hoist cannot be used in wet weather, high speed winds or after 23h00 (not negotiable).

Liability - The renter acknowledges that K2012116289 t/a The Daylight Studio is exempt from all liability & consequently the client abandons all recourse against K2012116289 t/a The Daylight Studio concerning:

- Physical injury which may be sustained in the premises by any person present.
- Material damages (damage to equipment, accessories, documents or any other asset). The client declares that all equipment & materials made available by The Daylight studio are in good working order and should any of the provided equipment & materials be damaged by the renter, the renter is liable for it's replacement.
- Thefts of, or damages to merchandise or equipment brought onto or left on the premises.
- Any costs as a result of power / electricity failure.
- Malfunction of the hoist.
- In the case of any unforeseen accident or force majeure event such as flood, fire, total or partial strike, lock out etc. This is not limitative.

Parking

- Clients are not permitted to park in garage of Bree Street Studios Building; parking is available at 17 New Church Street, to the right of the main entrance.

Payment terms & extras

- Payment is due on first day of rental with extras payable on receipt of extras invoice.
- Overtime (occupation including first delivery to last collection) will be charged @ hourly rate.
- Late payments are subject to interest fees.
- If bookings are not accurate (eg. Stills booked but actual shoot is for Film) the rate relevant to the ACTUAL shoot will be invoiced & the client will be liable to pay it.

Tips

- Daylight Studio Assistants may receive tips if the renter feels they have earned them.
